It is to be ensured that not a single faculty including Vice-Principal, Training Supdt, Workshop Supdt is left without participating in the evaluation work.

- 5. In case of such misuse if the faculty is a Guest faculty she/he may not be engaged in the next academic session and if she/he is a regular faculty, his/her case may be reported to D.D (Admin) for needful action. In both the cases the remuneration shall be cancelled.
